PART FIVE- Contract Terms

1. I/We understand that the school has based its operating budget and tuition rates on this contract to send my child(ren) to St. Anthony Catholic School and that my/our obligation to pay the tuition for the full academic year is unconditional and that after July 30, 2018, no portion of such tuition paid or outstanding will be refunded or canceled in the event of absence, withdrawal, or dismissal from St. Anthony Catholic School for any of the above named student(s). In the event of such separation from the school, the entire full year tuition balance becomes due and payable at that time.
2. I/We agree to pay all tuition listed on this contract by the method indicated. In addition to all other legal remedies available to enforce this contract, I/we understand if payments are not made in a timely manner that my/our child(ren) may not be allowed to attend school and that academic records and grades (including report cards) may not be released. If this account is referred for collection, then the undersigned promises and agrees to pay all collection costs. It is understood that the school will withhold the transcript of the record or report card of any student whose account is in arrears.
3. In view of this obligation, I understand that the option to participate in the Tuition Refund Plan is being made available to me at this time to protect a portion of my yearly financial obligation and I am still responsible for the full tuition. I have received and read the enclosed brochure detailing the terms and conditions of coverage concerning this Plan. It is imperative that Part 4 is completed for all students enrolled at SACS.
4. I/We agree to accept and cooperate fully with St. Anthony Catholic School in routine matters of rules, regulations, and discipline. St. Anthony Catholic School also reserves the right to suspend, dismiss, or deny enrollment to any student whose progress is unsatisfactory or whose conduct, general attitude, or habitual actions, or those of the parent(s) or guardian(s) are contrary to the interest of the school or in violation of the school's rules and regulations as stated in the school handbook which may be amended from time to time.
5. I/We acknowledge that all schools in the Diocese of Charleston are intended to be environments that educate, nurture and support students according to the basic Christian principles of charity and love of neighbor. Everyone involved in the development of children and youth – teachers, administrators, parents, family and friends – is required to behave in accordance with these principles. Our Christian principles provide that:
 - Parents or guardians are expected to work courteously and cooperatively with the school to assist the student in meeting the school's academic, moral and behavioral expectations.
 - Students and parents or guardians may respectfully express their concerns about the school operation. However, they may not do so in a manner that is discourteous, scandalous, rumor driven, disruptive, threatening, hostile or divisive.
 - Parents, guardians or other responsible adults who insult or abuse school personnel in the presence of other school personnel, students or parents or through the use of social media and the internet may be asked to withdraw their student from the school.
 - Conduct that materially disrupts class work or extracurricular activities or that involves substantial disorder will not be tolerated.

These expectations for students, parents, guardians or other responsible adults include, but are not limited to, all school-sponsored programs and events (e.g., extended care, athletics, field trips, etc.). The school reserves the right to determine, in its discretion, when conduct is of such a severe nature as to warrant immediate action without warning. The action may include removal of a family and its students from the school.
